1. Registration will begin at 5:15 p.m.
2. Players start with 30,000 in tournament chips.
3. All Levels are 20 minutes with Ten (10) minute breaks at the completion of levels 6, 10, 13, and 17.
4. Breaks may be added or adjusted based on Tournament Director's discretion.
5. Ante will come from the Big Blind ONLY. Ante is posted prior to Big Blind.
6. Play will be 9-handed. Final Table will be 9-handed.
7. **Late entries and re-entries are allowed during the first 6 levels.**
8. **Unlimited re-entries will be permitted.**
9. \$246 from each entrant goes to prize pool, \$30 withheld for house revenue, and \$20 is withheld for staff. \$4 per player will be withheld to fund any guarantees and the tournament leaderboard.
10. Prize pool will be guaranteed at \$10,000. Any shortfall on the guarantee will be paid from the MGM National Harbor Tournament Fund.
11. **A Guest who is registered by the start of the tournament and wins with a "High Hand" and maintains it by the end of Level 6 will receive the entirety of the tournament buy-in back. Aces full of Deuces is the minimum required qualifying hand.**
12. Must be an MGM Rewards member to participate.
13. Must be 21 years or older to participate.
14. MGM National Harbor Poker Room reserves the right to alter, change, or cancel any tournament.
15. Seating may be limited
16. The event will generally follow the Tournament Director Association (TDA) rules. This event is subject to National Harbor poker room's house rules, and any other applicable rules, with all decisions at the discretion of the poker room employee acting as the Tournament Director.
17. Winners will be paid in casino chips.
18. Winners must show a valid ID to collect winnings. Residents of foreign countries without a U.S. tax treaty are subject to withholding. Winners are responsible for any United States federal, state or local taxes and/or government fees that may be imposed in connection with the acceptance of the prize.
